Dear Bethel Family,

There is no doubt the Coronavirus (COVID-19) and the concern about it are impacting the world in a very rapid manner. It is normal to be concerned as we hear of people affected by this virus. We want to ensure you; we are encouraged that the Lord is still sovereign over all! Because we trust in the LORD, we will not be shaken! We will rest and trust in the LORD (Psalm 62:1-2, 56:3).

Last Sunday we mentioned a general, three-part plan for conducting ourselves through these days.

- 1. Trust in the Lord.
- 2. Use your head.
- 3. Trust in the Lord.

We acknowledge that taking this virus seriously will help slow its spread and is a way of doing good to others and trying our best to live peaceably with all men (Galatians 6:10, Romans 12:18).

We want to be Biblically wise, therefore we are expanding part two of our plan by implementing the following based on the information we have:

The information we have:

- Federally, gatherings have been limited to no more than ten at this time (President Trump, 3.18.20).
- The CDC guidelines for *Considerations for Postponing or Cancelling a Mass Gathering* that hold our greatest attention for our decision are as follows:

General Guidelines

- The number of people attending who are at greater risk of more serious illness after contracting COVID-19. Older adults and persons with severe pre-existing health conditions are thought to be at increased risk.
- The density of attendees within a confined area. Based on what is currently known about the virus, spread from person-to-person happens most frequently among close contacts (within 6 feet).

- The level of transmission in your local community and the level of transmission in the areas from which your attendees will travel.
- If there are ways in which to significantly reduce the number of attendees.

Minimal-to-Moderate Level Guidelines

Cancel community-wide mass gatherings (for example, >250
people; the cutoff threshold is at the discretion of community
leadership based on the current circumstances the community is
facing and the nature of the event) or move to smaller groupings.

(With the information we have gathered, our understanding of the discretion of community leadership is that gatherings have been limited to no more than 50. (Governor Bullock, 3.15.20))

The Plan We are Implementing

1. Regular Church Services

For the rest of March, from March 18th to March 31st, we will only have Sunday Morning worship service at 11:00 with the following caveats:

- **At-risk members**: If you are numbered among the at-risk, we encourage you to stay home for the time-being. The CDC is telling us that older adults and persons with severe pre-existing health conditions are thought to be at increased risk.
- **Sickness**: If you are sick please stay home. We often want to push through when we are sick, but in consideration of others, now is not the time to push it.
- **Church Greetings**: We will refrain from handshakes or other physical contact and greet each other with a smile and encouraging words.
- **Offering**: We will not pass the plates. The plates will be in the back when you exit for your convenience.

Children:

- There will be no Children's Church or nursery.
- Please make sure your children understand our temporary Greeting Guidelines and the importance of touching as little as possible.

- Children need to stay with their parents at all times. The Children's Library will not be open.
- **Special considerations** will be given to include the children during the service. We will suspend our current series for the time being.
- **2.** Wednesday Prayer/Bible Study/Children's Program *All activities are canceled during this time frame (Rest of March).*
- **3.** Vacation Bible School VBS will be canceled for the time being. We are very thankful for our willing volunteers who make this ministry possible, and we look forward to offering this ministry to our community at a later date with our full team.
- **4.** Men's and Women's Bible Study

 Bible studies will not meet during this time frame (Rest of March).
- **5.** Clean Team

The Clean Team is released from their duties during this time frame (Rest of March). The building will be sanitized by others who will follow the CDC recommendations.
